

## INTRODUCTION

MTWU and The Kamla Foundation recognises the need for inter organisational co-operation and communication with the wider international community.

MTWU and The Kamla Foundation will work closely together to meet the aims and development needs of joint initiatives that they deem appropriate. This formal understanding (MoU) between MTWU and The Foundation will underpin and support the ongoing co-operation and consolidate their respect areas of work.

## PURPOSE AND SCOPE

The purpose of this MoU is to provide the framework arrangement between MTWU and The Foundation that covers initiatives and the development of relationships with:

- i. Global/International Institutional Bodies
- ii. Global/International Understanding
- iii. The Sharing of best practice

The benefit of the MoU is that both MTWU and The Foundation will have a clear framework within which to make best practice decisions that support and enhance their respective organisations.


The benefit to potential beneficiaries and students is that their relationship with MTWU and The Foundation is seamless as both organisations work together to deliver a high quality beneficiary experience.

## 1. STATUS OF THIS MEMORANDUM OF UNDERSTANDING


- 1.1 This Document is not intended to be legally binding.
- 1.2 This Document may be basis for the preparation of formal contracts or agreements between the parties. For the purpose of implementing each specific contract or agreement of activity, both institutions shall prepare the necessary documentation which shall be the object of a Specific Agreement or Contract to be executed by the concerned parties.
- 1.3 The parties do not enter into any legal relationship unless and until such formal contracts or agreements are executed.

## 2. OBJECTIVE OF THE MoU

- 2.1.1 The objective of the MoU is that MTWU and The Foundation will work together to expand cooperation and exchange of ideas in areas of mutual interest and carry out programmes and activities in co-operation with each other.

2.1.2 MTWU and The Kamla Foundation will undertake programmes that impact on the lives of the most vulnerable in society, namely on areas such as;

- Women Empowerment,
- Poverty alleviation
- Social and civic rights and responsibilities
- Awareness of the plight of women
- Strengthening civil society
- Gender, Justice and Equality
- Water and Sanitation and Protected Drinking water
- Civic leadership and Development
- Hosting Seminars and Workshops
- Developing and dissemination of appropriate training materials

### 3. COORDINATION AND MANAGEMENT

3.1 To fulfil the aims and objectives of the MoU, each party shall appoint a Coordinator to develop and manage the joint activities undertaken, specific details of which will be set out in formal agreements. Any such formal agreements shall include:

- a) The responsibilities of each party
- b) An outline schedule of each activity
- c) A budget and sources of finance for each activity
- d) Management details for the delivery of each activity
- e) Other services deemed appropriate for successful implementation of the above.

### 4. PROMOTIONAL MATERIAL


4.1 All the promotional materials used by either party relating to this MoU must be submitted to the authorized representative of the other party for approval in writing prior to publication.

## 5. DURATION AND TERMINATION

5.1 The MoU shall become effective on the date that this document is executed by both the parties and shall remain in force for a period of three (3) years.

5.2 Upon the completion of this term, the MoU may be revised upon the assent of both the institutions and such renewal shall take the form of a new MoU or of a specific Agreement or Contract.


5.3 Either party may at any time terminate the MoU by the giving of 60 days written notice.

## 6. RELATIONSHIP BETWEEN THE PARTIES


Nothing contained in this Document shall be construed as constituting a joint venture, partnership, formal service arrangement of any kind between the parties or of appointing either party as an agent of the other.

This MoU may be varied or amended by mutual consent of the parties in writing and such variation or amendment shall become part of this MoU upon the giving of that consent.




