## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered in to and executed between the Mother Teresa Women's University, Kodaikanal and the Mangayarkarasi College of Arts and Science for Women, Paravai, Madurai.

This collaboration is signed between the Vice-Chancellor of Mother Teresa Women's University, Kodaikanal (Party 1) and The Principal of Mangayarkarasi College of Arts & Science for Women, Paravai, Madurai (Party 2)

Party 1 – Dr. K. Kala, Vice Chancellor, Mother Teresa Women's University, Kodaikanal.

Party- 2- Dr. Uma Baskar, Principal, Mangayarkarasi College of Arts and Science for Women, Paravai, Madurai.

(First Party and Second Party are here after jointly referred to as "Parties " and individually as Party) Whereas:

1. The First Party is a Higher Educational Institution Named:
  - a. Vice-Chancellor, Mother Teresa Women's University, Kodaikanal. First Party and Second Party believe that collaboration and cooperation between them will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
  - b. The Parties in tend to cooperate and focus their efforts on cooperation within the area of Skill Based Training, Education and Research.
  - c. Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.
2. The second party is a Higher Educational Institution named:

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES OUTLINED IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

### CLAUSE 1- COOPERATION

Both the Parties are united by common interests and objectives and they shall establish channels of communication and cooperation that will promote and advance their respective operations within the institutions and its related wings. The parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for each other.

First-Party and Second Party cooperation will facilitate mutual and effective utilization of the intellectual capabilities of the faculty of both the institutions providing significant inputs to them in developing suitable teaching/training systems keeping in mind the needs of the industries.

The general terms of cooperation shall be governed by this MoU. The parties shall cooperate as promptly as possible and enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU.

The term of Definitive Documents shall be mutually decided between the parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter hereof and shall supersede and prior understanding between the parties on the subject matter.

#### CLAUSE 2 -SCOPE OF THE MoU

The budding students from the institutions could play a key role in technological up gradation, innovation and competitiveness of an industry. Both parties believe that close cooperation between the two would be of major benefit to the student community to enhance their skills and knowledge.

Parties shall encourage the continue development between the institutions based on their respective academic and educational needs through joint programmes under this MoU.

Parties shall organize various programmes i.e., seminars, workshops, conferences, webinars, guest lecture programmes, training programmes and personality development programmes jointly or separately with the consent of other party relating to the students of the parties.

Parties shall encourage curriculum development of the department of both institutions and express their valuable suggestions for the up gradation of the curriculum.

Parties shall encourage the exchange of students in the context of professional training and knowledge empowerment programmes for the benefit of the students of both institutions.

Parties shall also permit staff exchange programme and express their willingness to handle classes for the transfer of theoretical knowledge among the students.

Parties shall provide support to the developmental activities by way of willingness to conduct invited lecture and training programmes for the benefit to the students and the faculty members in the areas identified and required by each other.

Parties shall provide the necessary facilities to conduct the above programmes in their premises.

Parties shall encourage collaborative research activities among the faculty members.

The Memorandum of Understanding is based on good faith and support is to be extended by both parties to conduct various programmes. Hence, such terms which are spelt could be discussed mutually and agreed there upon benefitting both the parties herein.

#### **CLAUSE 3- INTELLECTUAL PROPERTY**

Nothing contained in this MoU shall, by express grant, implication, estoppels or otherwise, create in either party any right, title, interest or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other party.

#### **CLAUSE 4 -VALIDITY**

This MoU shall be deemed to have been automatically rescinded after the expiry period of five (5) Years unless renewed for any further periods as per mutually agreed terms at a later stage.

#### **CLAUSE 5- RELATIONSHIP BETWEEN THE PARTIES**

It is expressly agreed that First Party and Second Party are acting under this MoU as independent contractors and the relationship established under this MoU shall not be constructed as a partnership.

Neither party is authorized to use the other party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other party, without the prior written consent of the other party.

Neither party shall have, nor represent itself as having any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other party, to pledge the other party's credit, or to extend credit on behalf of the other party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at the District headquarters of both the parties.
